## Minutes of the Streatham Society AGM held on 23 November 2020 by Zoom

Attendees. 7 members attended and the meeting was chaired by Russell Henman, Deputy Chair

It was noted that the Constitution of the Society had been amended to allow an AGM to be held by Zoom

1. Chair's report 2019/20. Covid-19 restrictions had caused meetings to be cancelled in March 2020 and the Society had since adapted to the situation by holding regular Zoom talks. The Chair thanked members of the Executive and other members of the Society for their hard work

2. The Treasurer reported a Surplus for the year of £416.45 for the year on a turnover of £7,913.13. The Society remained in a healthy position with cash reserves of £37,193.69 at 31 March 2020.

It was noted at the time of the AGM that, as a result of Covid the Society would be making a deficit for 2020/21 but had sufficient cash reserves for this not to have a significant impact to the Society's financial position

3. Mr Allen Brown was thanked for undertaking an Independent Review of the Financial Statements for the year ended 31 March 2020
4. No nominations had been received to be a Trustee of the Society and existing members of the Executive who are Trustees of the Charity agreed to continue to serve for a further year

## Streatham Society Annual Report 2020-21

Although the restrictions imposed by Covid 19 continued to affect our meetings it did at least allow time to reflect and reconsider our approach to coping in the short term and the longer term.

Firstly we initiated a series of very successful Zoom meetings which were well received and secondly we had been aware for a long time that the success of our meetings at Woodlawns had led to more demands for fewer places as our popularity increased so did the demand on space.

It was felt that a larger venue was needed and following discussions with the committee and St Leonards Church it was decided that, following a VERY successful meeting in September, all future meetings would be held in the church. The advantage of this is the increased visibility of the screen and more than adequate seating. We now look forward to the year ahead in a greatly enhanced venue and a number of interesting and lively speakers.

### Membership

Our paid membership for 2020 was 273. This was fewer than 2019 but good, considering we had no live meetings after March because of government restrictions. We welcomed 30 new members, £453 was donated with subscriptions. 141 members have supplied an email contact address. As live meetings ended in March it was decided that subscriptions should be waived for 2021. Therefore our income was much reduced.

### Publications

We have over 50 titles in our publications which are all advertised on our website: 32 Streatham Society titles and 27 John Brown Local History Publications. John publishes all our books. Lockdown restrictions have resulted in an increase in our online sales. Many of these were for our *Trails* as people took exercise walking around Streatham.

Despite this being a challenging year we remain excited and optimistic about the future. I would like to thank *all* the committee for their ongoing enthusiasm and hard work. They are: Janis Benson for running the book stall at the Recent Lambeth Heritage festival and all other events, Mark Berry for his work as secretary and on social media, Russell Henman for arranging speakers, Liz Burton treasurer who makes sure our money is spent



wisely,Robert Doyle for technical assistance .I would like to give a special thank you to our Newsletter editor Judy Harris for all the time and effort she puts into producing the excellent quarterly Streatham Society News which is always packed with news , photos, information , reports and dates for our diaries.Please keep sending her your news or memories of Streatham or other items that she can use when putting the magazine together.

***Note 2: Publications Income***

This refers to books, leaflets etc. bought online or in person from the Publications Officer.

***Note 5: Donations***

***Note 6: Publications***

These expenses relate to publications purchased from John Brown.

***Note 7: Printing, Postage and Stationery***

These expenses relate to the costs of producing and sending out The Streatham Society Newsletter, plus programmes, membership cards and general printing, copying and postage.

***Note 8: Insurance***

This is paid to the British Association for Local History (BALH).

***Note 9: Room Hire at Woodlawns***

In August 2020, we made a payment to Woodlawns of £1050.00. This constituted:

- a hire fee of £850.00 to cover the period from July 2019 to March 14<sup>th</sup> 2020
- a donation of £300.00 to cover the 6 meetings we were unable to hold from March 15<sup>th</sup> to June 2020.

***Note 10: Miscellaneous Expenses***

The miscellaneous expenses consist of:

- A payment of £143.88 to Liz Burton for funding the Streatham Society's copy of Zoom Pro, which allows us to hold online meetings.
- A payment of £177.84 to Mark Bery for two years' website hosting by Weebly.

**Total: £321.72**

***Note 11: Float for Bookstalls***

£51.00 was retrieved by Robert Doyle from the cash box at Woodlawns. This is cash which is used as a float for bookstalls, and should have been included in last year's accounts, but was forgotten about due to the sudden lockdown.

***Other Points to Note***

- The Society has suffered a deficit this year of **£3406.70**.

**Points to note:**

- In spite of this year's exceptional circumstances, publications income has pretty much kept pace with previous years, with the exception of 2020, which was easily our best year.
- In March 2020, when we were no longer able to hold in-person meetings, we made the decision to suspend subscriptions until meetings could start again. The period of suspension proved to be longer than we hoped, and has led to a significant drop in income for 2021.
- With no in-person meetings, we were unable to hold raffles or sell refreshments.
- Due to the move away from cheque payments and difficulties with our RBS bank account, we have stopped using the RBS account and are currently trying to close it.
- Our Lloyds deposit account holds **£15,554.12** which is invested for three years.


